2 Terms and conditions

Definitions	Adopter is the person identified at 1 above. Council is Blacktown City Council and BARC BARC is Blacktown Animal Rehoming Centre
Acknowledgement	1. The Adopter acknowledges that: 1.1. Council has advised them, to the best of its ability, about the history condition and temperament of the animal 1.2. the animal may require veterinary treatment and that it will be at their expense 1.3. Council is not responsible for any pre-existing health condition of the animal.
Obligations	2. Council will release the animal into the Adopter's care in consideration of the Adopter: 2.1. paying the Adoption fee 2.2. warranting that they will humanely care for the animal 2.3. if renting, having obtained approval from the Landlord/Real Estate Agent to have a family pet at the premises. There will be no refund of the purchase price of the animal if the Adopter returns the animal because approval was not provided by a Landlord/Real Estate. 3. Prior to release, Council will: 3.1. conduct a veterinary health-check of the animal 3.2. ensure the animal is Lifetime registered in NSW, desexed, microchipped and vaccinated.
Release	4. On release of the animal, the Adopter:



- 4.1. is aware that no blood tests have been carried out and the animal may be carrying a disease
- 4.2. accepts the animal in its current condition and acknowledges that Council makes no assurances or representations as to the future health or disposition of the animal
- 4.3. relieves Council from all liability for any or all costs associated with the animal's care, including but not limited to, future vaccinations and veterinary checks or procedures, whether caused by accident or illness, or as a result of either a pre-existing or future medical conditions suffered by the animal
- 4.4. relieves Council from all liability rising from any or all circumstances in connection with the animal
- 4.5. acknowledges that the animal has not been tested for hidden diseases (but adoption dogs 6+ months of age are heartworm-tested and all adoption cats 4+ months of age are FIV-tested).
- 4.6. has been informed if the animal requires any dental treatment and acknowledges that it will be at their own expense.

Future claims	5. This document may be used as a bar to any claim, action, demand or proceeding brought now or in the future by the Adopter against Council, in respect of all circumstances in connection with caring for the Animal
Understanding	6. The Adopter warrants that this Agreement in not made in reliance of any representation, promise, statement, conduct, or inducement by or on behalf of the Council, other than as recorded in this document 7. This animal has been examined by a qualified veterinarian and has been deemed suitable for adoption.
